## **Finance Committee Working Session**

Date: February 9, 2019

- 1. The meeting was called to order at 9:01 AM.
- 2. Joe moved and Bogart seconded to approve the minutes of the January 30, 2019 working session. Approved 5-0.
- 3. The committee reviewed and discussed the FY20 Farmington River Regional School District budget proposal. Of note is an 8.82% (\$127,392) increase in Sandisfield's assessment, substantially due to an increase in Sandisfield's enrollment from 92 students in FY19 to 97 students in FY20. Several questions were raised and will be directed to Eric Jesner, the School's business manager.
  - a. The committee agreed to ask the district for an enrollment list to confirm the number of Sandisfield students.
  - b. The committee will inquire whether there are options to mitigate Sandisfield's assessment increase (e.g. by reducing capital improvement funds or via offset from the district's Excess & Deficiency Fund).
- 4. The committee reviewed and discussed the Select Board's answers to questions on the FY20 operational budget request in the General Government Administration category.
