- 1. Meeting called to order at 6:33 pm by Barbara Cormier, Chair
- 2. Kurt and Aviva Wills- South Branch Farm, 40 Viets Rd, Sandisfield, MA ed a) Ms Alexsnder Glover-legal representation for the Wills, presented detailed written plans and designs formally drawn up by architects with all necessary legal requests. Discussion regarding non conforming or conforming structure. Redesigned structure with an open porch. The Planning Board directed the Mr and Ms Wills to apply for a special permit.
