Sandisfield Fire Department Regulations

Burning Permits

Open burning of brush is permitted between January 15th and April 30th, weather and safety conditions permitting. An Open Burning Permit application must be submitted to the Sandisfield Fire Department before beginning your burn.

Burning on unauthorized days is illegal and subject to fines and penalties!

Procedures for Obtaining and Activating an Open Burning Permit

Step 1: Complete Permit Application on the form itself or print and complete by hand.

Forms may be downloaded from this page or picked up at the Chiefs office during normal services/business hours. Hours are between 9:00 am to 5:00 pm, Monday through Friday.

Retain one copy to be available for inspection when burning.

Step 2: Confirm the permit each time you intend to conduct an open burn by calling (413) 258-4742 to be certain that burning is permitted that day. Calling times are from 9:00 am to 4:00 for next day burning.

1. Read and complete 2 copies of this form. Be sure all required information is filled in. This form is interactive and can be completed online and then printed.
2. Send one copy to Fire Department at above address. Keep one copy to be available at burn site.
3. Confirm the permit each time you intend to conduct an open burn by calling (413) 258-4742 to be certain that burning is permitted that day.

Conditions of Permit

1. The responsibility and all consequences of the open burn rest with the land owner.
2. The Sandisfield Fire Department may issue, postpone or cancel permits at any time.
3. You must call each time that you intend to use the permit.
4. The open burn will consist of Brush only and not be for commercial purposes.
5. All fires will be attended with sufficient personnel and equipment to control the burn.
6. All fires should be out by 4:00 p.m.
7. No open burns will be permitted closer than 75' from any structure (and further away if necessary).
8. Violation of these conditions may result in criminal charges, fines and revocation of this permit.
