Highway Dept Updates:

The worked on the Riiska Brook Bridge, drainage work on Route 183, culvert replacement, grading continues. John Burrows requested that a tire on the side of the road be picked up, they highway dept. will do so. Alice addressed pipeline issues. Kinder Morgan used a bridge on Hammertown Rd. even though Bob told them they couldn't. Bob spoke to them about not using Mountain Home Lane to turn their vehicles around.
