## Highway Dept. updates:

## Selectmen's updates:

John reviewed the fire at the highway garage on Sunday, Dec. 10. It was a total loss including vehicles and equipment. On behalf of the Selectboard John thanked our fire, police, emts, all the surrounding towns that responded for all their work. Reviewed the meetings that were held today with the Insurance adjusters, Mass DOT, Smitty Pignatelli, Representatives from the Governors office. Everyone worked well together. We have had many offers of trucks from several towns. Ralph presented a list of towns offering trucks. Mass DOT will be taking care of our paved roads. Our employees and contractors, if needed, will be taking care of the dirt roads. Broadband update, it is not a dead issue. John discussed this with Smitty Pignatelli and it is still an active issue.

Mark continues to work on the transfer station. He and Fred had a conference call with the DEP. We do have to clean the transfer station, potholes, land fill cap, tree work, water flow issues. They have extended the deadline to June 2018. Ralph Leavenworth asked if the highway department will be responsible for the cleanup. The selectmen responded that they will to an extent.
