

RESULTS OF THE SPECIAL TOWN MEETING
Monday, October 23, 2017

The meeting was called to order by Selectman John Skrip at 7:00 p.m. In the absence of the Moderator Barbara Cormier was nominated to fill the position of moderator for this meeting. There were 34 registered voters present along with Town Administrator Fred Ventresco. Meeting adjourned at 7:20 p.m.

Article 1: The Town voted by majority to amend Article 3 as voted at the Annual Town Meeting held on May 13, 2017 so that it reads to raise and appropriate for the Town Administrator \$75,000 for Fiscal Year 2018: \$60,000 for salaries and \$15,000 for expenses
Selectmen's approval: all in favor
Finance Committee approval: 3 in favor 1 opposed

Article 2: The Town voted by majority to amend Article 6 as voted at the Annual Town Meeting held on May 13, 2017 so that it reads to raise and appropriate for the Town Accountant \$27,284 for fiscal year 2018: \$18,284 for salaries and \$9,000 for expenses.
Selectmen' approval: all in favor
Finance Committee approval: 3 in favor 1 opposed

Article 3: The Town voted by majority to amend Article 11 as voted at the Annual Town Meeting held on May 13, 2017 so that it reads to raise and appropriate for the Treasurer/Collector \$56,686 for fiscal year 2018: \$40,296 for salaries and \$16,350 for expenses.
Selectmen's approval: all in favor
Finance Committee approval: all in favor

Article 4: The Town voted by majority to amend Article 19 as voted at the Annual Town Meeting held on May 13, 2017 so that it reads raise and appropriate for the Web Site Administrator \$4,450 for fiscal year 2018: \$2,700 for salaries and \$1,750 for expenses.
Selectmen's approval: all in favor
Finance Committee approval: all in favor

Article 5: The Town voted by majority to amend Article 65 as voted at the Annual Town Meeting held on May 13, 2017 so that it reads raise and appropriate for the Reserve Fund \$12,600 for fiscal year 2018.
Selectmen's approval: all in favor
Finance Committee approval: all in favor

Article 6: The Town voted by a 2/3 vote to appropriate \$420,000 for construction, rehabilitation and repair of the Rugg Bridge, including all incidental and related costs, and to meet this appropriation, that the Town transfer \$220,000 from the Stabilization Fund, appropriate \$100,000 from so-called Chapter 90 funds, and authorize the Treasurer, with the approval of the Board of Selectmen, to borrow \$100,000 pursuant to G.L. c. 44, sec 7 or 8 or any other enabling authority, and issue bonds and notes therefor, and further, that and further, that any premium received by the

Town upon the sale of any bonds or notes approved by this vote, less any premium applied to the payment of the costs of issuance of such bonds or notes, may be applied to the payment of costs approved by this vote in accordance with G.L. c.44 sec. 20, thereby reducing by a like amount the amount authorized to be borrowed to pay such costs.

Finance Committee approval: 3 in favor 1 opposed
