

COMMONWEALTH OF MASSACHUSETTS

SPECIAL TOWN MEETING

Berkshire, ss:

To the Constable of the Town of Sandisfield in said county, Greetings:

In the name of the Commonwealth, you are hereby directed to notify and warn the inhabitants of the Town of Sandisfield qualified to vote in elections and town affairs, to meet at the Sandisfield Town Hall, 3 Silverbrook Road in said Sandisfield, on Saturday, February 26, 2022 at 1 p.m. to act on the following articles:

ARTICLE 1. To see if the Town will vote to abandon that portion of West Street north of Cronk Road currently serving as a driveway to property now or formerly of Johanna Miner, which has fallen into disrepair and no longer serves the public interest, or take action relative thereto.

ARTICLE 2. To see if the Town will vote to accept the provisions of MGL Chapter 64N, Section 3, to impose a local sales tax upon the sale or transfer of marijuana or marijuana products by a marijuana retailer operating within the Town to anyone other than a marijuana establishment at a rate not greater than 3% of the total sales price received by the marijuana retailer as consideration for the sale of marijuana or marijuana products; or take action relative thereto.

ARTICLE 3. To see if the Town will vote to authorize the Select Board to dispose of a portion of certain town property located at the intersection of Sandisfield Road and New Hartford Road and identified as Assessors Map 201, Lot 0 – 13, on such terms and conditions as they deem in the Town's best interest; or take action relative thereto.

ARTICLE 4. To see if the Town will vote to amend Chapter III, Section 3 of the Town's Bylaws by striking Paragraph A. [Election of Town Clerk]

And further to amend Chapter III, Section 5 [The following Town Officers...not provided for heretofore, shall be appointed by the Selectboard] by inserting Paragraph H, as follows:

H. The Town Clerk.

This amendment shall become effective immediately; or take action relative thereto.

ARTICLE 5. To see if the Town will vote to transfer from available funds sums of money to augment the appropriation for the following accounts for the current fiscal year; or take action relative thereto.

- Treasurer Salary Account \$TBD

ARTICLE 6. To see if the Town will vote amend the General Bylaws by adding a new section to Chapter VIII as follows:

Section 17: Disposition of fees and other revenues.

Unless otherwise specified by the General Laws, all fees or other revenues collected by a Town officer or employee other than constables shall be paid into the treasury of the Town and shall not accrue to the benefit of any individual;

Or act in relation thereto.

ARTICLE 7. To see if the Town will vote to transfer from available fund \$18,679 for vocational school tuition, or act in relation thereto.

ARTICLE 8. To see if the Town will vote to transfer a sum of money from available funds to purchase and equip a Ford F-550 vehicle for the Department of Public Works, or act in relation thereto

And you are hereby directed to serve this warrant by posting true and attested copies thereof in three public places within the Town of Sandisfield fourteen days at least before the time of said Special Town Meeting.

Hereof fail not at your peril and make due return of the warrant with your doings thereon to the Town Clerk at or before the time of holding said Special Town Meeting.
