RESULTS OF THE ANNUAL TOWN MEETING May 13, 2006

The Annual Town Meeting was called to order at 10:03 a.m.. There were 71 registered voters present along with Town Council Jerome Scully. Moderator Barbara Cormier opened the meeting by thanking the American Legion for replacing the flag at the Town Hall and followed with the Pledge of Allegiance.

Article 1. The Town voted by majority to accept the reports of the Town Officers. The Town voted unanimously to raise and appropriate for the Moderator Article 2. \$400: \$150 for Salaries and \$250 for Expenses. Article 3. The Town voted unanimously to raise and appropriate \$200 for Administrative Costs for a Grant Writer. Article 4. The Town voted unanimously to raise and appropriate for the General Government \$28,446: \$22,046 for Salaries and \$6,400 for Expenses. Article 5. The Town voted unanimously to raise and appropriate \$12,057 for the Board of Selectmen's Secretary Salary. Article 6. The Town voted unanimously to raise and appropriate \$400 for Finance Committee Expenses. Article 7. The Town voted unanimously to raise and appropriate for the Board of Assessors \$30,395: \$21,750 for Salaries and \$8,645 for Expenses. Article 8. The Town voted unanimously to raise and appropriate \$6,000 for the Massachusetts Department of Revenue Mandated Triennial Recertification Expenses. Article 9. The Town voted unanimously to raise and appropriate the sum of \$600 to re-link the Assessors' database with the Town's digital tax map, current color orthophotos, topo maps and various MA GIS databases (includes wet lands and Title V overlays). The resulting information is used by the Assessors, Board of Health, Planning Board and the Conservation Commission. Article 10. The Town voted by majority to raise and appropriate for the Treasurer's Office \$19,010: \$13,855 for Salaries and \$5,155 for Expenses. Article 11. The Town voted unanimously to raise and appropriate \$1,000 for the Treasurer Tax Lien Expense. Article 12. The Town voted unanimously to raise and appropriate for the Tax Collector \$12,700: \$5,000 for Salaries and \$7,700 for Expenses. Article 13. The Town voted unanimously to raise and appropriate \$1,000 for Computer Technical Support for Town office computers. Article 14. The Town voted unanimously to raise and appropriate for the Town Clerk \$18,748: \$12,062 for Salaries and \$6,686 for Expenses.

Article 15. The Town voted by majority to amend Article 15 to read: To see if the Town will vote to raise and appropriate for the Town Clerk Archive Project \$5,000 or any other sum for Expenses.

The Town voted unanimously to raise and appropriate for Mowing and Maintenance of town properties and Cemeteries \$7,803: \$5,253 for Salaries and \$2,550 for Expenses and Equipment. Article 36. The Town voted by majority to raise and appropriate for the Protection of Persons and Property \$40,730: \$26,540 for Salaries and \$14,190 for Expenses. The Town voted unanimously to raise and appropriate for the Berkshire Article 37. County Sheriffs' Communication Center \$6,782 for Expenses. Article 38. The Town voted unanimously to raise and appropriate for the Fire Department and Ambulance Maintenance \$33,114: \$6,786 for Salaries and \$26,328 for Expenses. Article 39. Citizens' Petition #1 Proposed Article for Town Warrant Town of Sandisfield

Because the citizens of Sandisfield are concerned about the long-term health of our environment ; because Genetically Engineered crops have not been proven safe for humans or for the ecosystems with which the crops interact; because Genetically Engineered crops have been found to contaminate other crops and local flora through cross pollination causing unintended and unknown changes to their geology and because the U.S. Congress and Federal regulatory agencies have not adequately responded to these important concerns. We, the people of Sandisfield, would like to follow the lead of those in many New England Towns and Cities and more than 30 other countries in a resolution to:

- 1. Call upon our state and federal governments, including the Massachusetts Legislature, the U.S. Congress, the Environmental Protection Agency, the Food and Drug Administration, and the U.S. Department of Agriculture, to support the mandatory labeling of all genetically engineered foods and seeds and the full assignment of liability to the commercial developers of genetically engineered foods.
- 2. Encourage a local moratorium on growing genetically engineered crops until there is credible and scientific evidence that these products are not harmful to our health or our environment.
- 3. Send copies of this article to the elected representatives of this town, including the Massachusetts State Legislators, the Governor, the Commission of the Department of Food and Agriculture, and our Congressional Representative and Senators.
