which revolving funds together shall not exceed the sum of twenty-seven thousand five hundred dollars (27,000), which shall be under the control of the Town Treasurer, which shall be accounted for separately and to which shall be credited only the departmental receipts received in connection with the programs supported by each revolving fund; further to authorize the Town Treasurer to expend from such funds in accordance with Chapter 44 Section 53 E  $\frac{1}{2}$  of the General Laws, provided however that said expenditures for all revolving funds shall not exceed the receipts for such funds, or to take any other action relative thereto.

- Article 67. To see if the Town will vote to appropriate \$50,000 or any other sum from Free Cash to reduce the FY2006 Tax Rate.
- Article 68. To see if the Town will vote to authorize the Select Board to enter into an Inter-municiple Mutual Aid agreement with other Berkshire County towns for shared Board of Health services, or take any other action relative thereto.
- Article 69. To see if the Town will approve the Springfield Materials
  Recycling Facility Municipal Agreement with Recycle
  America Alliance and the Massachusetts Department of
  Environmental Protection for the receipt and processing of

the Town's recyclable materials at the Springfield Materials Recycling Facility for ten years. The Town will receive \$15.67 per ton of recyclables plus a share of the revenue generated from the sale of recyclables per the contract.

The Town Hall (3 Silverbrook Road) will open at 10 am Saturday, May 14, 2005 for the Town Meeting and the polls will be open on Monday, May 16, 2005 at 10 am at the Town Hall (3 Silverbrook Road) for Town Elections and shall be closed at 8 pm.

You are directed to serve this warrant by posing true and attested copies thereof at three public places with the Town of Sandisfield seven days at least before the time of said Town Meeting.

Hereof fail not and make due return of the warrant with your doings thereon to the Town Clerk at or before the time of holding said Town Meeting.
