

WARRANT FOR THE ANNUAL TOWN MEETING
May 15, 2010

To the Constable of the Town of Sandisfield

Greetings:

In the name of the Commonwealth of Massachusetts, you are required to notify and warn the inhabitants of said town, qualified to vote in elections and town affairs, to meet at the Town Hall (3 Silverbrook Road) Saturday, May 15, 2010 at 10:00 am for the transaction of town business and on Monday, May 17, 2010 at 10:00 am until 8:00 pm for elections of officers.

- Article 1. To see if the Town will vote to accept the reports of the Town Officers.
- Article 2. To see if the Town will vote to raise and appropriate for the Moderator \$300 or any other sum: \$150 or any other sum for Salaries and \$150 or any other sum for Expenses.
- Article 3. To see if the Town will vote to raise and appropriate \$1.00 or any other sum for Administrative Costs for a Grant Writer.
- Article 4. To see if the Town will vote to raise and appropriate for the General Government \$29,727 or any other sum: \$23,524 or any other sum for Salaries and \$6,203 or any other sum for Expenses.

which revolving funds together shall not exceed the sum of forty-one thousand five hundred dollars (\$41,500), which shall be under the control of the Town Treasurer, which shall be accounted for separately and to which shall be credited only the departmental receipts received in connection with the programs supported by each revolving fund; further to authorize the Town treasurer to expend from such funds in accordance with Chapter 44 Section 53 E1/2 of the Federal Laws, provided however, that said expenditures for all revolving funds shall not exceed the receipts for such funds, or to take any other action relative thereto.

Article 65. To see if the Town will vote to raise and appropriate \$4,100 or any other sum for the creation of a Town web site.

Article 66. To see if the Town will vote to authorize the Board of Selectmen to enter into immediate discussions with other Western Massachusetts municipalities with the intent of entering an inter-municipal agreement, pursuant to Chapter 40, Section 4A of the Massachusetts General Laws, for the purpose of establishing a universal, open access, financially self-sustaining communication system for the provision of broadband service, including high-speed Internet access, telephone and cable television to the residents, businesses and institutions of these municipalities; or act in relation thereto.
