

WARRANT FOR A SPECIAL TOWN MEETING

To the Constables of the Town of Sandisfield

Greetings:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify all inhabitants of the Town of Sandisfield, qualified to vote in the town affairs to meet at the Old Town Hall, 3 Silverbrook Rd., Sandisfield, MA at 6:30 p.m.


- Article 1. To see if the Town will vote to appropriate \$35,000 or any other sum For Tax Liability Expenses and to meet that appropriation transfer \$35,000 or any other sum from the Overlay Surplus Account to the Treasurer's Expense Account.
- Article 2. To see if the Town will vote to appropriate \$21,002.74 or any other sum for the Unemployment Fund and to meet that appropriation transfer \$21,002.74 or any other sum from the Overlay Surplus Account to the Unemployment fund.
- Article 3. To see if the Town will vote to appropriate \$18,000 or any other sum for the Town Administrator Salary and to meet that appropriation transfer \$18,000 or any other sum from the Stabilization Account to the Town Administrator Salary Account.
- Article 4. To see if the Town will vote to appropriate \$4,977.50 or any other sum for the Treasurer's Consultant Salary and to meet that appropriation transfer \$4,977.50 or any other sum from the Stabilization Account to the Treasurer's Salary Account.

Article 5. To see if the Town will vote to appropriate \$6,912 or any other sum for Employee Benefits and to meet that appropriation transfer \$6,912 or any other sum from the Stabilization Account to Employee Benefits.


Article 6. To see if the Town will vote to appropriate \$13,815.93 or any other sum for Yanner Park and to meet that appropriation transfer \$13,815.93 or any other sum from the Stabilization Account to the Yanner Park Special Revenue Fund Account for the improvements and maintenance of Yanner Park.

Article 7. To see if the Town will vote to appropriate \$16,000 or any other sum for the Police Department Software and to meet that appropriation transfer \$16,000 or any other sum from the Stabilization Account to the Police Department Expense Account.

You are directed to serve this Warrant by posting true and attested copies thereof at three public places within the Town of Sandisfield fourteen days at least before the time of said Town Meeting. Hereto fail not and make due return of the Warrant with your doings thereon to the Town Clerk at or before time of holding said meeting.


