

WARRANT FOR A SPECIAL TOWN MEETING

To the Constables of the Town of Sandisfield

Greetings:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify all inhabitants of the Town of Sandisfield, qualified to vote in the town affairs to meet at the Old Town Hall, 3 Silverbrook Rd., Sandisfield, MA at 6:30 p.m.

Article 1. To see if the Town will vote to appropriate \$4,706.92 or any other sum for a Fiscal Year 2018 Legal Services Bill and to meet that appropriation transfer \$4,706.92 or any other sum from Free Cash to Legal Services.

(requires a 9/10 vote)

Article 2. To see if the Town will vote to appropriate \$8,000 or any other sum for Legal Services for the remainder of Fiscal Year 2019 and to meet that appropriation transfer \$8,000 or any other sum from Free Cash to Legal Services.

Article 3. To see if the Town will vote to appropriate \$6,000 or any other sum for the ALSS Intercept Service and to meet that appropriation transfer \$6,000 or any other sum from Free Cash to ALSS Intercept Services.

Article 4. To see if the Town will vote to adopt the following General Bylaw under Chapter VIII Miscellaneous Provision, Section 14 Fines and Penalties, or take any other action relative thereto:

Non-Criminal Disposition

- Scope and Authority

This Bylaw provides for a non-criminal disposition of a violation of any Town Bylaw, the violation of which is subject to a specific penalty. This Bylaw is enacted in accordance with MGL c.40 §21D.

- Enforcing Person

“Enforcing Person,” as used in this Bylaw, shall mean any Police Officer of the Town of Sandisfield with respect to any offence; the Fire Chief and his/her designee; the Building

Inspector and his/her designee; the Public Health Director and his/her designee; the Director of Public Works and his/her designee; the Dog Officer and his/her designee and such other officials as the Board of Selectmen or Bylaw may from time to time designate, each with respect to violations of the Bylaws within their respective jurisdictions. If more than one official has jurisdiction in a given case, any such official may be an enforcing person with respect thereto.

- Fines

Notwithstanding any other provisions of this Section, when enforced pursuant to non-criminal disposition procedures of MGL c.40 §21D, the following shall be the fines applicable to the listed offenses, unless otherwise specifically provided by Bylaw.

First Violation: \$100

Second Violation: \$200


Third and Subsequent Violations: \$300

Each day a violation exists shall constitute a separate violation.




