**THE TOWN OF SANDISFIELD’S  
COMMUNITY CHOICE POWER SUPPLY PROGRAM  
RATE INCREASE NOTIFICATION**

**IMPORTANT UPDATE:** As the result of a change in law, the Town of Sandisfield’s current aggregation rate **will increase by \$0.002 per kWh effective with the July 2022 meter reads**. The new rate (increasing from \$0.10119 per kWh to \$0.10319 per kWh) will be fixed through the remainder of the term, ending January 2023.

**WHAT IS A CHANGE IN LAW AND HOW CAN IT RESULT IN A RATE INCREASE?** A change in law is a regulatory event that results in a direct, material increase in costs during the term of an electric power supply contract. At the request of ISO New England (ISO-NE), the Federal Energy Regulatory Commission (FERC) approved a unique fuel security contract with the costs associated with such contract imposed on all market suppliers. The fuel security contracts will support the continued operations of two generating units located just north of Boston and deemed critical by ISO-NE to maintain both fuel security and system reliability over the next two years (from June 2022 through May 2024). This cost allocation resulted in unexpected supplier costs, which in turn resulted in a rate increase effective with the July 2022 meter reads. **WHAT IS THE IMPACT OF THE RATE INCREASE?** Given average usage of 600 kWh per month, the new aggregation rate represents an increase of \$1.20 per month versus the current rate. The Town of Sandisfield is pleased to announce that **First Point Power** (“First Point”) has been selected as the supplier for its Community Choice Power Supply Program (“Program”). First Point will provide electric power supply for all consumers participating in Sandisfield’s Program. This notice is intended to tell you about this Program for electric power supply. In accordance with state law, it also informs you of your rights and options if you choose not to participate in the Program.

**YOU WILL NOT NOTICE ANY CHANGE IN YOUR ELECTRICITY SERVICE.** You will continue to see First Point printed under the “Supplier Services” section of your monthly bill. You will continue to receive one bill from Eversource. You will continue to send your payments to Eversource for processing. Eversource will continue to respond to emergencies, read meters and maintain the distribution and transmission lines. Reliability and quality of service will remain the same. Furthermore, you will continue to have all existing consumer rights and protections.

**PARTICIPATING CONSUMERS** will start benefiting from the aggregation rate beginning on the day of the month in July 2022 that their meter is read. This date varies by service area. Your meter reading date is shown on your bill.

**IF YOU ARE A BASIC SERVICE CONSUMER WHO HAS BEEN MAILED A NOTIFICATION** you do not need to take any action to participate. You will be automatically enrolled. If you do not wish to participate, please follow the instructions specified.

**BUDGET PLAN OR ELIGIBLE LOW-INCOME RATE CONSUMERS** will continue to receive those benefits from Eversource.

**SOLAR PANEL AND COMMUNITY SOLAR CONSUMERS** will continue to receive net metering or on-bill credits while receiving electricity supply under the Program and the value of these credits will not be altered by participating in the Program.

**ANY APPLICABLE TAXES WILL BE BILLED** as part of the Program's power supply charge. You will be responsible for identifying and requesting an exemption from the collection of taxes by providing appropriate documentation.

**TAX EXEMPT SMALL BUSINESS CONSUMERS** must email or fax a copy of their Energy Exemption Certificate directly to First Point at [enroll@firstpointpower.com](mailto:enroll@firstpointpower.com) or (877) 206-4855 (fax) in order to maintain their tax exempt status.

**IF YOU WISH TO JOIN THIS PROGRAM** you may OPT-IN at [colonialpowergroup.com/sandisfield](http://colonialpowergroup.com/sandisfield) **OR** call First Point at (888) 875-1711 and ask to be enrolled. If you are currently contracted with your own Competitive Supplier, you should confirm with them that you will not incur any early termination fees or penalties for leaving their supply.
